#### **NEW BUSINESS**

## Agency Land Management: Truck Purchase

The Commission reviewed a August 10, 2020 staff memorandum summarizing the bids received for the purchase — for the purpose of replacing a spent 1994 pick-up truck — of a 2020 Ford F350 quad cab with a cap; they are, in ascending order by price: (1.) Colonial Municipal Group, availability in twelve weeks, \$55,075; (2.) MHQ, availability in 2021, \$58,309; and (3.) Balise Ford of Cape Cod, availability in three weeks, \$60,369. \$66,000 has been budgeted for this item.

Mr. Peach recommended Balise Ford, owing to its timeliness. Commissioners discussed the value of such timeliness; Mr. Wells stated that, in his business, he will not necessarily take the lowest bid - "I take what is the best thing for the money." After discussion and by a motion made and seconded, the Commission voted unanimously to select Balise Ford.

### Doug's Cove Preserve (Town of Oak Bluffs)

Staff reported that the commonwealth is preparing to install a bicycle path on the east side of the Beach Road and that certain easements, temporary and permanent, will be needed. The staff of the environmental affairs office believes that, for those easements involving the land bank, a so-called Article 97 conversion will be necessary. The permanent easements are estimated to comprise 0.05 acres.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to support this project in concept, on a preliminary basis and subject to consideration of final documents. Staff will distribute pertinent materials to Commissioners for review.
