#### APPROVAL OF THE AGENDA

Hearing no proposed additions, Ms. Weaver declared the agenda approved as presented.

#### APPROVAL OF THE MINUTES OF JULY 22, 2024

By a motion made and seconded, the Commission voted in a roll call vote five in favor, none opposed and Mrs. Reimann abstaining to approve the minutes as written.

#### **NEW BUSINESS**

Agency Land Management: Farmland Leasing

The Commission discussed the two agricultural leases that are due to expire at the end of the year: (1.) Brian Cioffi at the Blue Barque Preserve; and (2.) Fred Fisher III at the Little Field Preserve. Each is eligible for extension through 2028 and Mr. Kisiel recommended doing so. After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to so extend each.

Agency Administration: Personnel and Staffing

The Commission discussed its ecology assistant position, currently occupied by Bryn Willingham. The job was designed to be rotating — each 24-month period a new assistant would be hired — but Ms. Russell stated that Ms. Willingham's performance is such that she recommends that the Commission suspend the rotation: prior to her current position Ms. Willingham held many others within the agency, which has given her invaluable experience in many management realms that aids productivity. Ms. Russell noted that she believes that when/if Ms. Willingham resigns, the rotation should resume.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to accept Ms. Russell's recommendation.

#### **ENDORSEMENT OF THE WARRANT**

The Commission endorsed Warrant no. 2025-08.

#### **EXECUTIVE SESSION**
