NEW BUSINESS

Agency Administration: Personnel and Staffing

The Commission discussed its standard employee housing contract, in which employees agree to live on a land bank property in exchange for providing after-hours oversight of the premises. Bryn Willingham, whom Commissioners voted to make a permanent employee at their August 12, 2024 meeting, is willing to do so for 40-44 Meetinghouse Way. She would reside in a portion of the bunkhouse there.

Commissioners variously discussed (1.) security at 40-44; (2.) the various housing units available there for staff; and (3.) the current occupancy of these units.

After discussion and by a motion made and seconded, the Commission voted unanimously in a roll call vote to enter into such a contract with Ms. Willingham.
