Tashmoo Preserve Summer 2024

Property Summary

Tashmoo Preserve was one of the least frequently attended properties in 2024 due to insufficient staffing. In 2024, the property had a summer rangers present a maximum of 3 days per week between June 16 and July 7. The property was attended for a total of 6 days throughout the 2024 season. The days attended occurred only on two Mondays, one Tuesday, one Thursday, one Friday, and one Sunday. Comparatively, Tashmoo Preserve was attended for 78 days in 2023.

In 2024, Tashmoo Preserve had a total of 663 visitors, 38 of whom were walk-ons and 58 were bicyclists. In 2023, Tashmoo Preserve had a total of 8,634 visitors, 816 of whom were walk-ons and 1095 were bicyclists. The average number of visitors per day in 2024 was 110.5, while in 2023 there was an average daily visitor count of 110.69.

Data Summary






Figure 1: Daily Average Property Usage

Due to insufficient staffing, there is limited data available to make comparisons across the years. Figure 1 compares the daily average property use in 2024 and 2023. Figure 2 compares the number of days attended across the years.

Figure 1 shows the average number of vehicles, dogs, and the maximum number of vehicles in the lot per day increased in 2024. Overall visitor counts, bicyclists, walk-ons, number of vehicles turned away, and time the parking lot was full decreased on average in 2024

compared to 2023. Looking at the daily averages for 2024, it appears property usage at Tashmoo Preserve was likely similar to that of 2023.





Tashmoo Preserve was attended 72 more days in 2023 than in 2024. Importantly, half of the 6 days Tashmoo Preserve was attended in 2024 occurred during July, which is historically the busiest month for the property.

Actions to be Taken in Coming Season

- 1. Prioritize this property when scheduling summer rangers due to the number of visitors.
- 2. Communicate with the town prior to the summer season about the presence of lifeguards so rangers can communicate with the public about if they are there or not.
- 3. If visitors arrive by vehicle and are unable to park due to the lot being full, summer rangers are encouraged to offer alternative beach destinations nearby (as long as the visitors are amenable to suggestions).
- 4. When possible, inform visitors of property boundaries to prevent trespassing onto abutting properties.
